Article 1 Subject

1.1 The subject of the contract shall be the **supply, delivery** of the following supplies:

Lot 1: One (1) new 4WD station wagon vehicle, and
Lot 2: Three (3) new 4WD pickup double cabin vehicles.

The place of **acceptance of the supplies shall be the President's Office Planning and Investment in Dodoma**, United Republic of -Tanzania, the time limits for delivery shall be <insert date and time> and the Incoterm applicable shall be

Delivery Duty Paid (DDP)⁴, excluding VAT and duties. The implementation period of tasks shall run from the countersignature of the contract to the date of provisional acceptance.

- 1.2 The contractor shall comply strictly with the terms of the special conditions and the technical annex.

Article 2 Origin

The rules of origin of the goods are defined in Article 10 of the special conditions.

When required, a certificate of origin for the goods must be provided by the contractor at the latest when it requests provisional acceptance of the goods. Failure to comply with this condition may result in the termination of the contract and/or suspension of payment.

Article 3 Price

- 3.1 The price of the supplies shall be that shown on the financial offer (specimen in Annex IV). The total maximum contract price shall be in Tanzanian Shillings (TZS) <insert price>
- 3.2 Payments shall be made in accordance with the general and/or special conditions (Articles 26 to 28).

Article 4 Order of precedence of contract documents

The contract is made up of the following documents, in order of precedence:

- the contract agreement;
- the special conditions
- the general conditions (Annex I);
- the technical specifications (Annex II [including clarifications before the deadline for submission of tenders and minutes from the information meeting/site visit];
- the technical offer (Annex III [including clarifications from the tenderer provided during tender evaluation]);
- the budget breakdown (Annex IV);
- [specified forms and other relevant documents (Annex V)];

The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they shall prevail in the order in which they appear above.

Article 5 Other specific conditions applying to the contract

For the purpose of Article 44 of the general conditions, for the part of the data transferred by the contracting authority to the European Commission:
