PART OF INCOMPLETE REFORMS UNDER PROCESS MENTIONED WITHIN THE BLUEPRINT FOR REGULATORY REFORMS TO IMPROVE THE BUSINESS ENVIRONMENT AND INVESTMENT CLIMATE IN TANZANIA

A. Introduction

The Blueprint for Regulatory Reforms in Tanzania since 2018 serves as a pivotal framework designed to advance Tanzania's business environment and investment landscape. While we recognize significant achievements of the reform process to support private sector development, there are some incomplete reforms. We are excited to highlight the significant progresses made so far and the promising trajectory ahead of the incomplete reforms to improve the business environment and investment in Tanzania.

B. Highlight on Key Areas of Focus of Government of Tanzania in reform to bolster Business Environment and Investment Climate in Tanzania:

1. Streamlined Business Registration: Efforts are underway to simplify the business registration process, significantly reducing the time and cost associated with starting a business in Tanzania. By leveraging digital technologies, aspiring entrepreneurs can now navigate the registration landscape with ease and efficiency. Currently, a company can be registered in less than 8hrs.

2. Tax Incentives and Compliance: The government is actively reviewing its tax policies to create an environment that encourages investment. Tailored incentives for both local and foreign investors are being designed to promote industrialization, while ensuring compliance with tax obligations in a straightforward and transparent manner. This is evidenced by the Government's decision to set up a Presidential Commission for Tax Reform in Tanzania.

3. Access to Finance: Recognizing the vital role that access to finance plays in business growth, reforms are being implemented to enhance the lending environment. Initiatives include: improving credit accessibility for small and medium-

sized enterprises (SMEs), fostering partnerships among financial institutions, businesses and international development partners.

4. Regulatory Transparency and Accountability: Efforts are being made to bolster transparency within the regulatory framework. By establishing clear communication channels and stakeholder engagement platforms, the government is committed to ensuring that businesses are informed and can participate actively in the reform process from the Central government to Local Government. Examples include: the process of Preparing the Blueprint for Regulatory Reform in Tanzania 2018; The Implementation Process and Impact Assessment Report 2024, all of which were participatory, and all documents are publicly available. This clearly confirms The Government of Tanzania's allegiance to private sector development.

5. Infrastructure Development: Investment in critical infrastructure is a key component of the reforms agenda. Improvements in transport, energy, and technology infrastructure are paramount to creating an enabling environment for business operations and logistics. The Government of Tanzania is leading in infrastructure development, a good example is the reduction in travel time between Dar es Salaam and Dodoma, from an average of 8hrs to 3.5hrs by SGR Train.

6. Capacity Building and Skills Development: There is an ongoing commitment to enhancing human capital through training programs and partnerships with educational institutions. These initiatives aim to equip the workforce with the necessary skills to thrive in a dynamic business environment.

C. Incomplete Reform on Process 2024

As we move forward with the completion of the implementation of the Blueprint for Regulatory Reforms 2018, we remain optimistic about the transformative potential this initiative holds for Tanzania's economy. The collaborative efforts between the government, private sector, and civil society are instrumental in driving these reforms. We expect more collaborations with the private sector in Tanzania as we move to review Blueprint 2025.

We invite stakeholders, investors, and entrepreneurs to engage with us, as we work towards completing this ambitious reform agenda and the review of the Blueprint for Regulatory Reforms 2025. Together, we can create a robust business environment that not only attracts investment but also fosters sustainable economic growth for all Tanzanians.
